A Dancer's Dream

A consistent training approach is crucial to your dancer's progress especially if their goal is joining or continuing on one of our Performance Teams. For that reason, our Performance Teams have an annual Summer Dance Hours requirement to maintain eligibility for participation in the following year's competition season. We are happy to work with your dancer's summer availability to help ensure they are able to meet required Performance Team Summer Dance hours for 2019-2020 season eligibility.

To meet your Performance Team dancer's required Summer Dance Hours most affordably, we urge you to plan your summer schedule to ensure your dancer can attend our group programming options outlined on our website's Summer Dance 2019 page. That said, if you are unable to meet your dancer's Summer Team Requirement via the outlined group classes, private & semi-private lessons can be available to you *as studio and teacher schedules permit*. While available to you, we again caution that private lessons (at \$80/hr), are definitely *not* the most cost-effective way to meet Performance Team participation goal. We, therefore, encourage you to re-consider a summer plan that enables your dancer to meet required hour commitment by attending existing (previously scheduled/posted) group classes.

If attending posted group classes is not possible for your dancer, or if they are able to only attend a portion of the existing group classes, **please use the attached Personalized Plan Request Form** to submit your dancer's availability for private/semi-private lessons. As well, please be sure to carefully review our [Team Requirements Page](#) for full details and expectations.

Age Eligibility: Dancers entering grades 2-12

Personalized Plan Schedule: to be determined based on studio, teacher, dancer availability.

Personalize Plan (private & semi-private) Lesson Fees

- Private Lessons (Solo) = \$40/30 min. \$80/60 min. \$120/90 min.
- Semi-Private Lessons (2 - 4 dancers) = \$45 per dancer /60 min.
- Pick-up Classes (5+ dancers) = \$30 per dancer /90 min.
- Late Booking Fee = \$25 per occurrence. (also applies to scheduling changes made after May 1st.).
- Private & Semi-Private class hours count one-for-one toward your Summer Technique hour requirement.
- Personalized Plans are *not* eligible for Early Bird Discounting. Any such discounting received in advance of private &/or semi-private scheduling will be revoked.

Cancellation Policy: No refunds will be issued if you cancel a private or semi-private lesson. Account Credit *may* be considered if *all* of the following occur:

- 1) we receive no less than 24 hour notice in writing (e-mail is acceptable),
- 2) lesson can be made-up within 14 days,
- 3) studio & teacher availability can be arranged within 14 days.

Please note: We will do all we can to accommodate your summer schedule, however, this in no way guarantees your required hours will be met in this manner. ***We strongly suggest gaining your required summer dance hours within the standard Dance Dayz Programming.***

for Team Eligibility 2019-2020 Season**



Today: Please notify us *immediately* and in writing if you foresee that your dancer will require a Personalized Plan. We require advance written notice (Dancer's Personalized Plan Request Form) including *all* days, dates, and times your dancer WILL be available throughout the Summer for lessons.

May 1st, 2019: Your Personalized Plan *Deposit \$575 is due in full on or before May 1st, 2019. We cannot begin scheduling lessons until Deposit and Completed Request Form have been received.

*Because the nature of this plan includes private &/or semi-private lessons, there *will* be an additional balance due. Private &/or semi-private lessons will be invoiced and payable upon booking/scheduling. We will aim to combine dancers in semi-private or group classes as often as scheduling lines up to help keep your cost down. That said, we cannot guarantee such groupings will be available as scheduling has historically been challenging at best. A great way to better reach the goal of grouped lessons is for you to speak with other Personalized Plan families to come up with dates that work for you all together. Bring that info to us and we'll do our best to match available teachers and studio time with your group!

July 1st, 2019: All private & semi-private lessons must be scheduled, confirmed and any additional assessed fees paid in full by July 1st, 2019 (lessons can be *attended* throughout the summer, but must be *booked & paid in full prior to* July 1st). Any lessons requiring administrative scheduling attention after the 1st of July will be charged a late booking fee.

August 31, 2019: All Summer Dance Hours must be completed by August 31, 2019 to be meet Performance Team 2019-20 Eligibility Requirements.

- It's dependable! Your payment is punctual (even if you're out of town), eliminating potential late charges.
- It's more secure! ACH is federally regulated. Unlike credit cards, ACH accounts are rarely compromised.
- **It SAVES YOU \$\$\$!** ACH provides administrative efficiency to keep your overall fees as low as possible.

Your ACH Authorization:

You will be charged for your dancer's Summer Registration and/or Personalized Plan via ACH per amounts indicated on your dancer's registration form &/or Personalized Plan Lesson Fees Table only. Your payment will appear on your bank's statement as an "ACH Debit." (For easy accounting on your end, we include a memo note clarifying payment application). Most of your banks will notify you via e-mail at time of transaction (if you set up notifications with them). You agree that no *prior* notification will be provided by us *unless* the date or amount changes.

*Admin Fee:

Please keep in mind, our entire reason for utilizing an ACH payment process is to AVOID raising your fees! **IF** you are unable to provide an ACH Authorization, the cost of that loss in efficiency will be applied to your dancer's account \$15/per payment transaction. This fee will be due and payable with your Summer Registration and/or Personalized Plan Deposit and, separately, for any account balance payments due.

If the above noted periodic payment dates fall on a weekend or holiday, I understand the payment may be executed *on the prior business day*. I understand, because this is an electronic transaction, these funds may be withdrawn from my account as soon as the above noted periodic transaction dates. In the case of an ACH Transaction being rejected for Non-Sufficient Funds (NSF) I understand A Dancer's Dream, Inc. will attempt to process the charge again within 30 days, and I agree to an additional \$35.00 charge for each attempt returned NSF which will be initiated as a separate transaction from the authorized recurring payment. I acknowledge that the origination of ACH transactions to my account must comply with the provisions of U.S. law. I agree not to dispute any authorized recurring billing with my bank so long as the transactions correspond to the terms indicated in this authorization form.
